

Love My Burb – Families Week 2026

Terms and Conditions

1. Participation

The *Love My Burb Project* is a community initiative delivered by Communicare Group Limited (hereafter referred to as Communicare) in partnership with the City of Gosnells, City of Armadale, and the Shire of Serpentine-Jarrahdale as part of CfC Families Week.

By submitting an entry, participants confirm the declarations set out in the submission form and agree to these Terms and Conditions.

2. Eligibility

Entry is free and voluntary.

Entrants must be residents, community members, or service users within one of the participating local government areas.

Participants under 18 years of age must have consent provided by a parent or legal guardian.

3. Photo Submission Requirements

By submitting a photo, the entrant confirms that:

1. They are the original photographer and copyright owner;
2. The photo is their own work and has not been copied from another source;
3. Consent has been obtained from all identifiable people appearing in the photo, including parents or guardians for children; and
4. The photo does not infringe on any copyright, privacy or other legal rights.

4. Image Use and Licence

Entrants retain copyright in their submitted images.

By submitting a photo, entrants grant Communicare and the relevant City/Shire a royalty-free, non-exclusive, perpetual licence to use, reproduce, edit, and display the image for the purposes of:

1. Community engagement and promotion;
2. CfC Families Week and *Love My Burb* initiative activities;
3. Public display in libraries and community spaces; and
4. websites, social media, newsletters, reports, presentations, and other communication materials including digital communications.

Images will not be used for commercial sale.

5. Selection and Display

Photos may be selected for display by the relevant City or Shire.

Selection does not guarantee ongoing display and remains at the discretion of the organising partners.

6. Image Storage and Retention

Entrants acknowledge and agree that:

- copies of submitted images may be retained by Communicare and/or the relevant City/Shire;
- images may be shared between Communicare and the participating City/Shire; and
- images may be stored electronically and reused in future materials related to the initiative.

7. No Payment

No payment, royalties or compensation will be provided for participation or for the use of images.

8. Privacy

Personal information and images will be handled in accordance with applicable privacy laws, including the *Privacy Act 1988 (Cth)*.

Reasonable steps will be taken to ensure images are used respectfully and appropriately.

9. Withdrawal of Consent

Consent may be withdrawn for future use of images at any time by contacting Communicare in writing. Withdrawal of consent will not affect images already published or produced prior to the request.

10. Liability

To the extent permitted by law, Communicare and the participating Cities/Shire do not accept responsibility for any loss, damage, or claims arising from participation or public display of images.
